H. Shoop, of the Recipient's office gave her report on what is going on at the recipient's office. There was a provider's meeting to set up new policies in the Emergency Financial Assistance. This included technical assistance to teach the providers how to enact the new policies. Currently, the recipient's office is starting a three-year program in partnership with UC-San Francisco to bring RAPID Start to the Las Vegas TGA. H. Shoop also shared the services provided by number of units and clients by service category. H. Shoop also shared the Part A Expenditures Report and the amount of carryover requested. T.
