subject: Winding Down Ryan White Part A Services - Clark County, NV

Pending Board of County Commissioners approval on new contracts resulting from RFQ 607247-24, some agencies are preparing to end certain service categories for which they were not recommended for funding.

This memo pertains to the Clark County area of the Las Vegas TGA. The service categories that will be ending by May 31, 2025 per agency are listed below:

Access to Healthcare Network (AHN)

- Medical Case Management
- Medical Nutrition Therapy
- Food Bank/Home Delivered Meals
- Health Education/Risk Reduction
- Medical Transportation-Bus Passes

Aid for AIDS of Nevada (AFAN)

- Early Intervention Services
- Medical Case Management
- Health Education/Risk Reduction
- Medical Transportation-Bus Passes

Community Counseling Center (CCC)

- Medical Case Management
- Psychosocial Support Services

Golden Rainbow

- Emergency Financial Assistance
- Health Education/Risk Reduction

To support a seamless transition, please take note of the upcoming changes for referrals to the agencies listed above.

Medical Case Management (MCM)

- April 15, 2025 is the last day to submit referrals for <u>new clients</u> to AHN, AFAN, and CCC.
- After April 15, 2025, referrals should only be sent to AIDS Healthcare Foundation, Community Outreach Medical Center, Dignity Health, Southern Nevada Health District, and UMC Wellness.
- Starting in June 2025, CAN Community Health and The Center will have MCM services available as well. Details on when referrals can begin to these agencies will be released in the near future.

Medical Nutrition Therapy (MNT)

- April 15, 2025 is the last day to submit referrals for new clients to AHN.
- After April 15, 2025, referrals should only be sent to Dignity Health and Southern Nevada Health District.
- Starting in June 2025, UMC Wellness Center will have MNT services available as well. Details on when referrals can begin to this agency will be released in the near future.

Food Bank/Home Delivered Meals (FB/HDM)

- April 15, 2025 is the last day for referrals for new clients to AHN.
- After April 15, 2025, referrals should only be sent to Dignity Health. Clients may also be referred to Three Square for food assistance. More information can be found by clicking on this link.

Health Education/Risk Reduction (HE/RR)

- April 15, 2025 is the last day to submit referrals for new clients to AHN and Golden Rainbow. Referrals should not be sent to AFAN at any time, as their HE/RR services stopped on February 28, 2025.
- After April 15, 2025, referrals should only be sent to Dignity Health.
- Starting in June 2025, The Center will have HE/RR services available as well. Details on when referrals can begin to this agency will be released in the near future.

Emergency Financial Assistance (EFA)

- May 19, 2025 is the last day to submit referrals to Golden Rainbow for <u>any EFA</u> <u>services</u>.
- Referrals to CAN Community Health and Chicanos Por La Causa may begin on June 2, 2025.
- Clients may also be directed to HOPWA-funded agencies that provide rent and utility assistance. A list of providers can be found at this link.

Medical Transportation (MT) - Bus Passes

- May 19, 2025 is the last day to submit referrals to AFAN and AHN for MT bus passes.
- After May 19, 2025, referrals should only be sent to AIDS Healthcare Foundation.
- Starting in June 2025, agencies funded for MCM will have the ability to distribute bus passes to the client they case manage. Those include AIDS Healthcare Foundation, CAN Community Health, Community Outreach Medical Center, Dignity Health, Southern Nevada Health District, The Center, and UMC Wellness Center.

Medical Transportation (MT) - Rideshare

- May 19, 2025 is the last day to submit referrals to Impact Exchange for MT rideshare services.
- Referrals to Dignity Health may begin on June 2, 2025.
- From May 20, 2025 through May 30, 2025, for clients who are newly diagnosed or returning to care, contact the Rapid stART Response Team at 855-RAP1DNV / 855-727-1368

Psychosocial Support Services (PSS)

- May 19, 2025 is the last day to submit referrals for new clients to CCC.
- After May 19, 2025, referrals should only be sent to Dignity Health and Community Outreach Medical Center.

Early Intervention Services (EIS)

- AFAN can provide EIS services, including HIV testing, through May 30, 2025. They will link clients who are newly diagnosed or returning to care to the Rapid stART Response Team for linkage to medical care and other needed services.
- Other agencies funded to provide EIS services include AIDS Healthcare Foundation, CAN Community Health, Southern Nevada Health District, and UMC Wellness Center.
- Starting in June 2025, The Center will have EIS services available as well. Details on when referrals can begin to this agency will be released in the near future.
